FHA Catalyst Claims COVID-19 Bulk XML Instructions

NOTICE: XML Version 1.7 will be required for all Bulk Submissions starting May 20, 2023.

Prior to May 20, 2023, the current production XML schema (version 1.6) is compatible for most submissions, but for those who are submitting Claim Type 32 (Loan Modifications) they will need to use the new XML format (version 1.7) and include the relevant changes noted below. Claim type 32 is the only claim type within FHA Catalyst that allows both HAMP and COVID programs and has no default set for the new Claim Designation field.

- Add \$500 incentive fee for claim type 33-National Emergency Partial Claim under <ADDITIONAL CLOSING COSTS AT SETTLEMENT>
- Add Claim Designation field with three allowed values ("COVID", "HAMP" or null) after <FORM_TYPE> For example:
